To incorporate Industry internship project in curriculum structure APEC approved two mode. Lot of deliberation was occurred on this item, Prof. L. M. waghmare, Prof. V.B. Borghaate, Prof. V. L. Manekar has suggested and stress upon to take out project phase –I and clubbed in 8th semester. After discussing both the mode Academic Council approved new modified curriculum structure of B.Tech. Civil Engg., Mechanical Engg., Electronics and Telecommunication Engg., Computer Science and Engg., IT, Instrumentation Engg. to be implemented from academic year 2020-2021 with following suggestions / modifications.

- Combined two courses viz. Project stage I, & Project Stage II should be converted to A. Project or
 B. Industry Internship Project as one course in eighth semester
- In eighth semester all courses should be elective
- Total credit of eighth semester must be maximum 17 and minimum 14





- In eighth semester only theory Elective courses are allowed except Project or Industry Internship Project.
- Shift seminar in seventh semester which is of 1 credit.
- After declaration of the list of internship student project batches, allotment of guides can be formed along with formulation of project topic in seventh semester and vacation gap between seventh and eighth semester can be utilized for literature survey and for doing some minor work such as fabrication/simulation depending upon methodology to be adopted.

All Chairman BoS shall submit the corrected curriculum structure to member secretary academic council in Hard and Soft Copy on or before 17/09/2020. The member secretary with consent of principal shall upload the same on Institute website immediately.

Academic Council approved the following modifications in existing curriculum structure

- Students going for Internship at Industry will complete theory courses through online platform such as MOOCs, NPTL etc or by self-study mode and will either directly appear for ESE only (Total internal marks (CT I + CT 2) will be awarded proportional to marks secure in ESE) or they can appear for CTI and CT2. TA marks will be awarded as per industrial project performance.
- 2. Academic Council approved to add two electives viz. ITU703 (G) Information and Cyber Security and ITU804 (F) Machine Learning Techniques in the existing structure of seventh and eighth semester of Information Technology program with restrictions on number of electives should be four and course code and prefix of the course name should be unchanged.

Chairman BoS IT shall submit the Modified curriculum structure and syllabus of final year IT to member secretary academic council in Hard and Soft Copy on or before 17/09/2020. The member secretary with consent of principal shall upload the same on Institute website immediately.
