To discuss and approve the recommendations of 36th meeting of Examination Committee held on 13th September 2020 at 4.30 pm regarding the mode of conduction of summer 2020 Theory and Practical / Oral examinations for final semester students and their pending backlog subjects in view of COVID-19.


Member Secretary informed the Academic Council that based on the guidelines issued by UGC, Department of Higher and Technical Education, Government of Maharashtra and Sant Gadge Baba Amravati University, Amravati, institute has prepared its guidelines for conduct of Summer 2020 theory and practical examinations for final semester students and their backlog courses. The proposed model of conduct of Summer-2020 examination was approved by Examination Committee in its 36th meeting held on 13th September 2020 was presented before the house. There were due deliberations among Hon. Members of Academic Council on whole proposal of mode of conduction of summer 2020 examination. The Academic Council approved the item with following modifications in the proposal and empowered Hon. Chairman, Academic Council to make modifications in above guidelines and schedule, if required. The same shall be placed before the Academic Council in next meeting for ratification.


In the schedule of examination at serial number 5 it is modified as Conduction of Final semester regular (who could not appear in S-2020 on valid ground and accepted by concerned Institute committee) and backlog courses examination (Summer Term -2020) applicable to regular students.
