Presentation and discussion on the curriculum structure of B.Tech.(First Year only) in light of NEP-2020 and to approve the same

Academic Council noted and approved the curriculum structure of B. Tech. (First Year only) suggested by NEP -2020 implementation committee formed at institute level, subjected to the minor modifications stated below. Council directed to all program BOS to take further approval from BOS to curriculum if it is required.

- 3.1 The course content of AIML subject offer in Semester- I shall be modified as per suggestions given.
- 3.2 To adjust the credits of Program Core PC1 department specific core course in semester II as 2 for theory and 1 for lab for those branches where it is required.
- 3.3 Program Board should once again check the Course outcome framed for each subject and use Blooms Taxonomy.
- 3.4 Delete unit labels from curriculum document.
- 3.5 In semester I for communication skill to keep lab of 2 hours instead of 1tutorial without changing the credits
- 3.5change the title of course CS1203 offered by CSE Program to UG 1 st year from object oriented paradigm with C++ to new title computation thinking with Python.

However Prof. V.M.Jape COE raised the issue against the implementation of B. Tech. first year curriculum suggested by NEP-2020 implementation committee constituted at college level and asked for permission to alter few subjects as per their need, which is also approved by their BOS. Prof. G. G. Bhutada, Head, Instrumentation Engg. also point out the same issue .The chairman allowed this point for discussion and elaborate to all members that this time as institute got very less time to implement NEP-2020 curriculum and the structure suggested by NEP committee constituted at college level incorporated all the guidelines directed by state government in their Govt. resolution so this time the institute should stick up to common curriculum suggested by NEP-2020 implementation committee, However with the time whatsoever changes will be required shall be studied in details and shall be included in next year. The Academic council agrees with this and gives approval.
