### Activities for Institute Level Round:

1. Interested eligible candidates must report in person at the venue and submit non-refundable admission **processing fee Rs. 1000/- (One thousand only)**. Mode of payment will be either DD drawn in favor of "Principal, Government College of Engineering Amravati", online through SBI collect or cash. In case of online payment candidate must produce payment receipt at reporting.
2. Verification of applicable original documents as notified by CET Cell and submission of one set of Xerox copy of these documents.
3. Display of Merit list of reported candidates.
4. Call for seat allotment by counseling to available seat
5. Submission of Institute Admission Fee
6. Seat allotment based on available vacancy
7. Submission of required original documents
8. Confirmation of the allotted seat to the candidate
9. Issue of allotment letter to the candidate
