Item-2:- To approve and submit a proposal to the Academic Board regarding extension of Maximum period of completion of degree for B.Tech. as a SPECIAL CASE

- As per autonomy rule R.28, the maximum duration for the Completion of UG Program is 12 Semester (6 years) from date of initial registration. The student has to apply for an extension of one year beyond six years to Academic Board. The Student **Mr. Mahesh B Khajone** (ID 10003010), has taken admission in Academic Year 2010-2011 and has already completed Maximum Period of completion of degree (12 Semester) and one additional year given by Academic Board, means the students have

already completed 07 years from their date of admission. He has applied for additional year to complete his degree. Mr. Mahesh B Khojane is in final year and has two backlog of final year. EEU702 Linear & Digital Integrated Circuits and EEU802 Electrical Drives and Control.

2. Since above student has already completed 07 years which exceeds the Maximum period for completion of B.Tech degree, hence SPECIAL CASE
3. Regarding Summer Term


