<u>Item-2:- To approve and submit a proposal to the Academic Board regarding extension of Maximum period of completion of degree for B.Tech. as a SPECIAL CASE</u>

- 1. As per autonomy rule R.28, the maximum duration for the Completion of UG Program is 12 Semester (6 years) from date of initial registration. The student has to apply for an extension of one year beyond six years to Academic Board. The Student Sagar M. Nakade (ID 12005050), has taken admission in Academic Year 2012-2013 and has already completed Maximum Period of completion of degree (12 Semester) and one additional year given by Academic Board, means the students have already completed 07 years from their date of admission. He has applied for additional year to complete his degree. Sagar M. Nakade is in final year and has one backlog of third year, CSU501 System Programming,
- 2. Since above student has already completed 07 years which exceeds the Maximum period for completion of B.Tech degree, hence SPECIAL CASE
- 3. After detailed deliberation and due consideration to all aspects, the Academic Board has approved the extension of one additional year for completion of degree for B.Tech. as a special case to Sagar M.
