## Item No 3: To approve new curriculum structure and syllabus of B.Tech. first year to be implemented from academic year 2019-20

Academic Board principally approved new curriculum structure and syllabus of B.Tech. first year to be implemented from academic year 2019-20 with following suggestions/modifications.

- Assign course code SHU100 to Induction Program
- SHU121 Optics, quantum and semiconductor physics shall be read as Physics
- SHU122 Integral calculus, differential equation and num. methods shall be read as Integral calculus and differential equation
- In Evaluation scheme swap the sequence of MSE and TA
- EEU121 Basic Electrical Engineering shall be of 3 credits.
- Text Books and Reference Books shall be in proper format.
- Introduce new course **Basic Mechanical Engineering (2 Credits)** for only Electrical, Electronics & TC, Computer Science, Information Technology and Instrumentation Engineering branch and **Basic Electronics Engineering (2 Credits)** for only Civil and Mechanical Engineering branch.

Chairman BoS, Mechanical Engineering and Electronics Engineering were informed to submit syllabus of Basic Mechanical Engineering (2 Credits) and Basic Electronics Engineering (2 Credits) respectively to Chairman BoS Science & Humanities. Academic Board authorized Principal to approve above modified structure and syllabus incorporating the above suggestion.

Chairman BoS, Science & Humanities was informed to provide revised first year curriculum structure and syllabus as <u>per above</u> and submit to member secretary Academic Board in hard and soft copy on or before <u>16/09/2019</u>. The member secretary shall upload the same on Institute website immediately.

Academic Board instructed to arrange two day workshop regarding course objective and course outcome for all faculty. Head, Electrical will arrange such workshop. After workshop, all course objectives and outcomes shall be revised and BoS Chairman, Science and Humanities will compile the report from all BoS Chairman and should submit the detail report to member secretary Academic Board.

Item No. 7: To approve and recommend to BoM the award of degree to the students who completed successfully B. The Board congratulated all B.Tech./M.Tech. students eligible for award of degree. Academic Board approved and recommended the list for approval to Board of Governance with following suggestions –

- i) The spelling (English and Marathi both) of students' name and the programme name should be carefully checked before submitting the lists to Sant Gadge Baba Amravati University, Amravati (SGBAU).
- ii) The final lists (after approval from Board of Governance) should be submitted to SGBAU, Amravati for further necessary action.

In view of the Graduation Ceremony scheduled on 31/08/2019, Academic Board authorized the Chairman (Academic Board) to approve the additional lists consisting of the students of B. Tech. # 9.1)To approve the additional lists of students eligible for award of degree from Sant Gadge Baba Amravati University, Amravati. (A proposal from Examination Committee)

Member Secretary informed the Academic Board that degree eligibility of 10 students of B. Tech. and 36 students of M. Tech. was received after 36<sup>th</sup> meeting of Academic Board. As decided in 36<sup>th</sup> meeting of Academic Board, approval to this additional list was given by Chairman Academic Board. The same additional list was placed before the Academic Board for approval.

Academic Board accorded post-facto approval to additional lists of students eligible for award of degree from Sant Gadge Baba Amravati University, Amravati.

## 9.2) To decide suitable grade for cancellation of performance due to unfair means.

As per item No 3.1 of 32<sup>nd</sup> meeting of EC, a committee was constituted to recommend suitable grade for cancellation of performance due to unfair means. The committee recommended grade 'CC'. However EC recommended using single letter and approved letter 'Y' for this grade.

Academic Board approved grade 'Y' for cancellation of performance due to unfair means.

# 9.3) To approve proposed modifications in rule R18.5, R18.5.1 & R18.6 for B. Tech. and R15.5. R15.5.1 & R 15.6 for M. Tech. [Make up examination]

Member Secretary informed the Academic Board that in order to have uniformity in procedure for make up examination of CT & ESE, modifications are proposed in the above rules. Proposed modifications as recommended by EC were placed before the committee.

# 9.4)To modify punishment for carrying Mobile / Smart watch / Programmable calculators during Examination (ESE / CT) (Th. & Pr.)

As per Rules and Regulations for Examinations and Evaluations of UG and PG Programmes, punishment for carrying mobile during examination is to take undertaking from examinee. In view of repeated incidences of carrying mobile during examination, there is need to impose more severe punishment so that misuse of modern communication technology during examination can be avoided. EC recommended following modification in Annexure B of Rules and Regulations for Examinations of UG & PG programs at Sr. No. 25.

## 9.5) To approve and recommend proposal for award of gold medals to the topper students of M. Tech.

Member Secretary informed the Academic Board that Institute has policy for award of gold medals to the topper students of each B. Tech. program from academic year 2009-10. It was proposed to award gold medals to the topper students of each M. Tech. program from academic year 2018-19. The proposal was placed for discussion in EC.

After thorough discussion in EC, EC approved and recommended that in view of small group size for M. Tech. programs, instead of Gold Medal, certificate to M. Tech. toppers should be issued.

Academic Board approved the recommendation of EC

# 9.6) Request for releasing mobile phones ceased as proof of unfair means ( Request by students Shaunak Sakhare and four others)

In EC meeting in view of the request made by the students and submission made by Dean (Student welfare) about difficulties faced in storing and handling these mobiles, Hon Chairman EC suggested that mobile should be returned to the students after the action taken on unfair means cases is approved by the EC. Due acknowledgement for this should be taken. Also to avoid legal complications which may arise in future, an undertaking / affidavit should be taken. Dean (Student welfare) shall design single format for receipt cum affidavit in consultation with legal advisor. After approval to this format, mobiles should be returned. Considering the fact that mobiles ceased since the inception of this rule are to be returned, notice may be displayed on web site to collect mobile within one month failing which balance mobiles will disposed off as per rules.

Academic Board approved the above policy. Academic Board suggested that to curb the malpractices there shall be CCTV camera in examination Halls/rooms. Data Center will look in to the matter and submit the report.

## 9.7) Proposal to conduct End Semester theory examination at institute level

Presently ESE is conducted at department level with departmental head working as coordinator. It is observed that very few students (sometimes 2 or 3 only) appear for Summer Term and to conduct their examination minimum staff required is 8.In order to avoid such financial expenditure, for administrative convenience and smooth conduct of examination, it is proposed to conduct the ESE at institute level.

EC approved the proposal with recommendation to implement it from Winter 2019 ESE.

The modalities for this shall be prepared by CoE and Dean (Acad) and shall be placed for approval in next EC meeting.

Modalities recommended by EC shall be placed before Academic Board for approval in next meeting. Academic Board approved the proposal

# 9.8) Proposal to cancel provision of attending classes and appearing for CT1, CT2 and TA for back loggers.

As per the provisions of Rule No R14.9 for B. Tech. and R 13.6 for M. Tech., students are permitted to register as back logger for the courses in which he/she has 'F' or 'Z' grade. Since this registration is during regular semester, all rules and regulations of regular semester are applicable to these students. Because of this, students need to attend the classes regularly and appear for CT1, CT2 & TA evaluation. Since these students register for regular courses as well as back log courses simultaneously, adjusting the time-table becomes difficult. Hence most of the time such students fails to make up required attendance and are declared "NOT ELIGIBLE" for ESE. To avoid such situations it is proposed to allow these students to appear for ESE directly without attending the classes. So far as performance in CT1, CT2 & TA is considered, it may be carried forward from immediate last performance or marks proportional to his / her performance in ESE may be considered for CT1, CT2 & TA taken together.

EC accepted the proposal in principle with option of giving marks proportional to ESE marks for (CT1, CT2) / MSE & TA. The proposal shall be effective from Summer Term 2020. EC further recommended to place the recommendations before Academic board for necessary approval.

## Academic Board approved the above proposal with following modifications

So far as performance in CT1, CT2 /MSE, TA & ICA is considered, it may be carried forward from immediate last performance or marks proportional to his / her performance in ESE may be considered for CT1, CT2/MSE & TA taken together & ICA in case of practical as per student's option. Option once given will not be change at any later stage. This is applicable for the courses in which student has 'F' grade only.

The proposal shall be effective from Summer 2020.

# 9.9) Proposal to complete audit courses by Direct second year admitted students before registering for Seventh Semester

The students admitted directly to second year needs to clear some courses as audit courses. Since there is no defined time limit to complete these courses, it is noticed that students have tendency to register for these courses during last year. If these students fail to clear the audit course, course completion certificate is not issued to them because of which many times placement of the student is also cancelled. Hence it is proposed that all audit courses must be completed by directly second year admitted students before registering for

Seventh Semester. Any students with pending audit course from directly second year admitted group shall not be eligible for admission to seventh semester.

EC approved and recommended the proposal.

Academic board approved the proposal applicable for Direct second year students admitted in 2019-20

## 9.10) Proposal to modify rule R 15.5 (for equivalence and absorption) for direct admission to Second year

Following modification is proposed in rule R 15.5 for B. Tech.

In that case percentage of the diploma certificate shall be considered for the absolute grading system. It shall be assumed that the student had earned credits of earlier semesters and shall earn the requisite number of credits and audit courses as per norms.

EC approved and recommended the proposal.

Academic Board approved the proposal.

### 9.11) Proposal for separate passing for ESE

As per existing rules, students securing 40% & 50% marks in a course in B. Tech. & M. Tech. respectively is considered 'pass' irrespective of his score in ESE. Due to this, if student gets good marks in CT1, CT2 & TA in some course, there is tendency of giving less importance to ESE of such courses. This results in neglecting about 50% contents of syllabus. To avoid this, it is proposed to have separate passing for ESE. Accordingly, it is proposed that keeping passing limit unchanged, additional requirement of minimum 1/3<sup>rd</sup> of ESE maximum marks is to be included. The proposal is placed before the board for further recommendation. If approved, same will be implemented for first year students from academic year 2019-20 and progressively in the following years.

It was point of discussion, whether student securing good marks in CT1, CT2 & TA in some course, is giving less importance to ESE of such courses and all exams should have equal importance.

Academic Board instructed CoE to present statistic in next meeting. Academic Board also suggested that to declare the average CGPA of the Institute

## 9.12) Proposal to modify grade calculation process for Summer Term

Presently, the grade calculation for Summer Term is defined in Rule R21.9 for B. Tech. It is proposed to modify this procedure. The proposed modification is presented in following table.

The record copy of that evaluation including the statistical parameters will be provided to the Course Coordinator by the Chairman, BOS or the First Year Class Coordinator as the case may be. However, in no case the highest grade awarded will exceed B+.	For less than 15 students in a course, the grades shall be awarded on the basis of natural cut-off in the absolute marks (Appendix D).  For 15 and more number of students in a course the statistical method shall be used for the award of grades with or without marginal adjustment for natural cut-off. The salient features of statistical method are given in Appendix-E.  However, in no case the highest grade awarded will exceed B+.

Academic Board approved the modification.
