## NCC First Year Enrollment/Admission Notice 2023-24

1. The students of **second semester** engineering of all the branches of GCoEA are hereby informed that the enrollment process (**Physical and Online Mode**) of admitting GCoEA students into National Cadet Corps (NCC) is proposed to start from 09th August, 2023 under open vacancies of GVISH, Amravati by 8 Mah. Battalion, NCC, GVISH, Amravati for the tentative vacancy position of 09 cadets (05 SD and 04 SW).
2. Date and time of the selection process (**Physically Present and Online Mode**) will be informed to the students as and when it is finalized by the Commanding Officer (CO) 8 Mah. Battalion, NCC, GVISH, Amravati.
3. To prepare the necessary aspects of the selection process grouped in three stages; Written test (MCQ based) on GK, NCC as an organization, Armed Forces of India, followed by online and offline interviews and final selection process by / at 8 Mah. Battalion, NCC, GVISH, Amravati. **Only 2<sup>nd</sup> semester GCoEA students (Result Awaited)** of all the branches (Girls and Boys) who are interested in joining NCC *Voluntarily* should *forward/register their names to the NCC Cell, GCoEA up to 23rd July, 2023 by 05.00 pm on the Google form link, given at the end of this letter. Late registration will not be entertained.*

4. **NOTE: Final selection of GCoEA students in NCC shall be subject to their Pass result of First Year B. Tech. (1<sup>st</sup> & 2<sup>nd</sup> Semesters) which may be awaited during the selection process.**

5. As per the requirement of NCC and order from the Commanding Officer, 8 Mah. Battalion, NCC, Camp GVISH, Amravati:

**Only Physically Fit Students as Certified by a Govt. Doctor/Registered Medical Practitioner will Be Selected in the Final Selection Process.**

Therefore,


**Medical Fitness Certificate from a Govt. Doctor /Registered Medical Practitioner is Compulsory to be Submitted by the Student at the time of Reporting for the Final Selection Process.**

6. The detailed instructions including required Medical Standards from the NCC Unit are attached with this letter. All interested students must read and strictly follow the instructions given by the NCC Unit including the Standard of Physical Fitness for Senior Division Cadets (Boys and Girls) attached with this letter. Any deviation in the prescribed rules, regulations, norms and medical standards shall not be entertained in the selection process.
7. Final selection of cadets will solely be the decision of the CO, NCC Unit, 8 Mah. Battalion, NCC, Camp GVISH, Amravati and that shall remain final.
8. Students should make their own arrangements to reach and appear for the selection process (in case of physical presence/Offline mode) at GCoEA and the Unit of 8 Mah. Bn. NCC, GVISH Campus Amravati. Students are advised to strictly follow the Govt. of India and Govt. of Maharashtra rules and advisories for Covid-19 as and when notified, if any.
9. The enrollment form attached with this letter should also be filled and should be brought by student at the time of reporting for the selection process. Online registration and enrollment is also to be done by the candidates.
10. Students should bring their original college ID card, Medical Fitness Certificate, Parent's Consent Letter, photocopies of their Aadhar Card, 10<sup>th</sup> Class Marklist (Proof of Date of Birth) and First Year Engg. Marklists (1<sup>st</sup> & 2<sup>nd</sup> semesters) for the verification purpose. Also bring 10 passport size photographs.
11. Students are advised to come prepared for the physical test as mentioned in the attached letter (eg. Running, Push-ups, Jumping, vision-test etc.) Students should keep with them their own water bottles and light refreshment in view of day long physical test and documentation process along-with Track Suit, Sports shoes, Caps etc.
12. Students should bring in **Consent of their Parents (format attached with this letter)** to attend the NCC enrollment selection process and subsequent selection in NCC without fail. This original written consent should be attached with the enrollment form. This is a necessary and mandatory part for the students appearing in the NCC selection process.

13. The NCC unit and this institution shall not be responsible to provide any travel arrangements, food arrangements, lodging and boarding arrangements and safety for students (and their companions, if any) appearing in the NCC selection process.
14. Date & Time of the selection process and Tests would be communicated to the students through college website/Whatsapp messages. Students are advised to prepare themselves in the areas of NCC, Indian Armed forces, General Awareness, Group Discussion, Public Speaking etc.
15. This NCC Unit and GCoEA shall try hard to complete the selection process in the second week of August, 2023 itself. However, in case of delay, students will be informed accordingly and are requested to cooperate with the authorities.

3. The eye sight shall be as follows :-

(a) Vision, without aid of glasses, is NOT less than 6/60 with each eye; provided that, with the aid of glasses, his vision is NOT less than 6/9 in one eye and 6/18 in the other.

(b) Each eye will be examined separately and be required to read the tests in ordinary daylight.

(c) Inability to distinguish the principal colours will NOT be regarded as a cause for rejection, but the fact will be noted in the enrolment form.

(d) Degree of acuteness of vision will be entered in the enrolment form as follows :-

LADY OFFICERS AND GIRLS CADETS

1. The candidate must be in good mental and bodily health and free from physical defect likely to interfere with the efficient performance of military duty.
2. Her height, weight and chest measurements should be noted.
3. The examination for determining the acuteness of vision includes two tests; one for distant, the other for near vision. The Army Test Types will be used for the test for distant vision, without glasses at a distance of 20 feet, and for the test for near vision without glasses, at any distance selected by the candidate. The standards of minimum acuteness of vision with which a candidate will be considered fit are as follows:

(a) Each eye must have a full field of vision as tested by hand movements.

(b) Squint or any morbid condition of the eyes or of the lids of either eye liable to the risk of aggravation or recurrence will cause the rejection of the candidate.

(c) Each eye will be examined separately, and the lids kept wide open during the test. Inability to distinguish the principal colours will not be regarded as cause for rejection but the fact will be noted in the proceeding and the candidate informed.

(d) The degree of acuteness of vision of all candidates for commission will be entered in the proceeding in the following manner-

(e) No relaxation of the standards of vision will be allowed.

4. The following additional points will then be observed—

(a) That her hearing is good and there is no sign of ear disease.

(b) That her speech is without impediment.

(c) That her teeth are in good order. She must have 10 sound teeth in the upper jaw, functionally opposed to 10 sound teeth in the lower jaw. Two of these teeth in each jaw must be molars. Well filled teeth will be considered as sound.

(d) That her chest is well formed and that her lungs and heart are sound.

(e) That she is not ruptured.

(f) That she does not suffer from severe Varicose Veins. A candidate who has been successfully operated upon will be accepted.

(g) That her limbs are well formed and developed.

(h) That there is free and perfect motion of all joints.

(i) That her feet and toes are well formed.

(j) That she does not suffer from any inveterate skin disease.

(k) That she has no congenital malformation or defect.

(l) That she does not bear traces of previous acute or chronic disease pointing to an impaired constitution.

(m) That she has been vaccinated successfully (or twice unsuccessfully) within the last five years.

(n) That she does not suffer from any chronic Gynaecological disorder.

(o) That she is not pregnant. In support of this she candidate will be required to produce a certificate signed by a medical officer.
